1.	<b>Apologies for absence</b> Received and accepted from Councillors Adams and Mortimer.	
2.	<b>Declarations of Disclosable Pecuniary Interests and requests for dispensations under Section 33 of the Localism Act 2011</b> None.	
3.	<b>Public Participation Session</b> Richard Parkes of Shropshire Youth Association spoke in relation to a request from the youth club for a grant towards a temporary extra youth worker. It was reported that due to an increase in younger members of the group, extra support was needed for part of the summer term, to give the opportunity for new youth workers to be trained in the interim. The clerk highlighted that the funding received for the youth club from Shropshire Council has increased to £1300, due to the distribution of funding between the clubs in the LJC area having altered.  It was also reported that the youth club wanted to use softballs in the hall. Councillor Blyth noted that there has been damage previously as a result of this.	
4.	<b>Planning Matters</b>  <b>a. Planning Applications for comment</b> i. <b>17/00407/FUL – Cartref Caravan Park, Ford Heath</b> Erection of extension to existing amenity building; change of use of land for 15 no. static caravan pitches; formation of wildlife pond and associated landscaping works; installation of foul pumping unit (resubmission) <b>The council reviewed the amended plans. It was the PC's understanding that the amenity building is no longer being extended. It was <u>RESOLVED</u> to maintain the objections because the revised plans do not address any of the other objections it raised so its previous objections stand, apart from the objection relating to the amenity building.</b>
