MINUTES OF COUNCIL MEETING HELD ON TUESDAY 19th SEPTEMBER 2023, AT 7PM, AT THE URWICK ROOM, FORD VILLAGE HALL

43/2324 PRESENT, APOLOGIES FOR ABSENCE

Apologies received from Cllrs. Paterson and Wells.

45/2324 PUBLIC PARTICIPATION SESSION

The following concerns were raised:

Speeding traffic /road safety

- Childminders drop offs at Dinky's Hill very fast driving.
- Speeding by school.
- Resident on A458 seen a big increase in speed. Four accidents on crossroads in last 6 years.
- House on corner nearly hit as cars turn corner.
- Crossing main road unsafe.
- Motorbikes unsafe driving/overtaking swerved into oncoming traffic to avoid sleeping policeman.
- Cross Gates Meadow cats being killed at night.
- Pulling out of Cross Gates Meadow road is so straight for such a period that speed builds
 up. Cars often don't slow until near petrol station. Struggle to slow down in time. Need
 some sort of physical barriers like speed bumps.
- Vehicles tailgating/intimidating driving.
- Noise level from lorries.
- Chavel resident see people speeding up and not slowing. Get a lot of overtaking at Chavel junction.
- Poor adherence to speed limit.
- Narrow pathway Chavel to Ford wind rush from trucks.
- Potential impact of more houses.
- Not enough signage and lot of what is there is faded.
- Suggest traffic island on Butt Lane head on A458.
- Need crossing for A458.
- Speed checks need to be done in week at peak times not weekends.
- Speed camera?

Cllr. Carlyle commented that at Loton WI in Alberbury, Mr John Campion is coming on the first Thursday in October at 2pm. She suggested people come and question him.

The chairman said that the PC has been working behind the scenes in regard to these issues. Key points:

- Local Policing Community Charter speed and school safety key issues. Met with previous village constable May 2021 – was going to write to try and bid for the motorcycle traffic sped enforcement team to visit Ford. Was raised again with R Walters earlier this year
- 2) *Met Highways England Nov 2021* to discuss speeding issues and asked for fading 40mph signs to be replaced. Mar 2023 put temp signs up
- 3) Monitoring ANPR camera pilot on A488 some public. Some teething issues.
- 4) Looked at grant aid for upgrading VAS people asking for it.
- 5) Police cover 300 sq miles which limits how much they are in Ford.

Cllr. Evans comments:

- *Police cover* speeding and visibility in parishes. Police priority from higher up is videos of shoplifting and town-based issues. Leaves little time for rural areas.
- Police officers increased but not back to 2010 level, especially when you factor in growth over the last 13 years.
- Chief Constable held to account by John Campion. Chief Constable finishes soon and new
 one being appointed. It was suggested to write to Mr Campion publish in newsletter and
 can write to him.
- Public advocating community action
- *Cllr. Evans led ANPR project as part of his role at Hanwood* consortium of councils on A488. Vehicles travelling at higher speed are reported to the police, for educational action. ANPR cameras not used for prosecution. The cameras have had a positive effect.
- Cllr. Horn asked for speed gun volunteers 4 years ago but had no community volunteers
- Welshpool Rd problems coming off the main road especially in reservation as turn right. An island has been suggested.
- VAS signs on lampposts need updating.
- Speed on main A458 needs to be slowed down.
- Cllr. Evans said SC have contacted Highways England, as had Ford PC Cllr. Evans said residents can contact the local Highways England Office Richard Timothy on 07849 078655.

The clerk suggested requesting ATC counters on main road to establish speeds at all times of day.

Actions:

- Request from Highways England ATC on main road.
- CSW ask police to come out and assess the site. Needs 6 /7 volunteers.
- Write to the MP and PCC.
- Publicise WI meeting.

A member of the public reported anti-social behaviour and swearing at the playground and a person being threatened with a weapon. Some of the perpetrators are late primary/early secondary. The chairman expressed his concern.

Action: Clerk to highlight this issue to the police.

47/2324 **PLACE PLAN**

Mathew Mead explained about Place Plans. In summary, they set out the community infrastructure needs of areas across Shropshire. They are currently being reviewed. Place Plans are split into projects of different levels linked to different funding pots.

STRATEGIC – essential infrastructure on a major area, typically covering a wide area .g. NWRR.

LOCAL – key services in an area like schools, doctors.

NEIGHBOURHOOD – parish level projects

It was noted that Highways England have put nothing forward for the A458-MM said he can take this forward through the External Infrastructure Group

Projects for Ford

It was **RESOLVED** to agree the following:

Community safety on A458 is key —house building will increase in/out traffic — CIL Local being sought to fund an island. Cost unknown, timescale within a year.

HIGH PRIORITY

- Roundabout at head of Butt Lane to safely manage traffic flow.
- Enforce current speed limits and assess need for reduction to 30 mph limit on Welshpool Road
- Upgrade the VAS signs to smart ones that show speed.
- Pedestrian crossing to the garage on A458
- Bus shelter A458
- School parking and pick up/drop off and considering lower speed limit in vicinity
 of the school. SC highways don't think issue asking from strips on the road. M
 Mead suggested ask Safer Schools' team shared with school travel plan coOrdinator.

MEDIUM PRIORITY

- Pedestrian and slow signs on Back Lane -
- Mirror by the telegraph pole at entrance to West View to aid visibility when pulling out.
- Allotments £30,000
- Village hall improvements.
- Flooding Jacksons Bank and sewerage leakage.
- Shoot Hill flooding.
- Broadband.

Action: Clerk to submit projects and incite Safer Schools Team to visit Ford, looking at school travel plan.
