  - Community Enablement Team under notice of redundancy. Now planning to put them in to the Local Plan team. Some debate in SC around this process.
  - Local Plan Review about to be published.
  - SC looking at budget very closely.

13 per session. Not always enough volunteers. Needs community support. SYA fee will be £4000 next year. £15 room hire per session. The club needs new equipment. A youth club AGM will be called for January.
