# MINUTES OF COUNCIL MEETING HELD ON 19<sup>TH</sup> JUNE 2018 AT FORD VILLAGE HALL AT 7PM

#### 22/1819 **PERSONS PRESENT AND ACCEPT APOLOGIES FOR ABSENCE** It was **RESOLVED** to accept apologies from Cllrs. Hanmer, Jones, Mapp and Mortimer.

*a)* To approve and sign the minutes dated 15<sup>th</sup> May 2018 It was **<u>RESOLVED</u>** to approve the minutes as being a correct record and they were duly signed by the chairman.

# 27/1819 **REPORTS**

- *a)* Shropshire Council
  - **Community Enablement Team** it is possible the team may be redundant or transferred to other areas of SC. Cllr. Evans concerned as they fulfil a vital liaison role for parish councils. Cllr. Clyne asked the parish council to continue to support this service.
  - SC staff now back on the Green Book re terms and conditions and pay.
  - Local Plan Review progressing but meetings yet to happen between SC and parish councils.
  - **CIL** SC has decided that of the money collected the balance for SC will be used to satisfy strategic needs of SC in the Place Plan area which is Shrewsbury. Cllr. Evans concerned this may not benefit the parishes. Cllr. Evans encouraging parishes to revisit Place Plans. Cllr. Clyne asked about Neighbourhood Plans. Cllr. Evans outlined what they are and the cost and timescales.
  - A5 to be closed, 11 July for 4 weeks, Mon to Fri (one side of carriageway at a time) to allow works on Woodcote Roundabout.
  - Various roads in Ford to be resurfaced letters to be going to neighbours.
  - Youth budget £12,000 budget for the LJC. £1,000 rurality grant has been applied for by Ford Youth Group and the LJC supported this but the panel awarded £500 rurality grant. Cllr. Evans has appealed this. Minsterley PC are undecided as to if they will fund their youth club. A second funding round will be in the autumn.
  - LJC –a working party is looking at the LJC areas and whether to re-align them with the Place Plan areas.

*b)* Youth Club No report.

### c) Ford Village Show

Cllr. Clyne reported that planning is well underway and the programme is being issued shortly. He encouraged people to attend on show day, 8<sup>th</sup> September 2018.

# d) Ford Village Hall

Cllr. Walton reported there is a meeting tomorrow for people who may be interested in joining the committee.

#### e) Other parish councillor reports

Cllr. Walton reported on one of the Facebook pages someone had found Great Crested Newts in their garden on Manor Crest. She asked if the Parish Council should look into this further. The clerk advised that they could contact SC or Shropshire Wildlife Trust for advice.
